Chairman Lundberg called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. Roll Call: Supervisors Braun and Young, Treasurer Jacobson and Clerk Wiggins present. Meeting notice postings were verified.

**MINUTES** of the February 8, 2016 Regular monthly meeting were approved as read.

**INFORMAL PUBLIC COMMENT** Jerry Okonek asked if additional lakeshore zoning changes would be forthcoming.
