REPORTS, DISCUSSION and ACTION

Fire Department: One response in March. Ten SCBAs will be purchased at a cost of \$375.00 each.

Jim Tolbert, Director, Burnett County Emergency Management: Introduced himself and gave a brief overview of his job. Long-term power outage emergencies are being addressed. A workshop for town officials will be held August 3, 2017 at the Government Center.

Operator License: Motion (Young/Braun) to approve an operator license for D. Kay; motion approved 2-0.

Zebra Mussels: Richard Reever of the Fish Lake Association presented information on the recent infestation on Middle Big (/s/ KW) McKenzie Lake, and requested that the information be put on the town's website to get the word out to the public.

Law enforcement: Drug use continues to be a serious problem.

Recycling: The town board will meet with Republic Services 3/29 to discuss a resolution to three years' overcharges, and review the proposed new contract.

Roads: Road inspection is finished, and the town will contact the county regarding contracting to rebuild Hanscom Lake Trailway this year. It was noted that Oak Lake Road on the south end of the lake needs repair.
