**BOARD MEETING**  
**April 14, 2014**

The regular monthly meeting of the Scott Town Board was held Monday, April 14, 2014 at the Scott Town Hall. Chairman Peterson, Supervisors Lundberg and Young, Treasurer Kipping and Clerk Wiggins were present. A quorum being present, the meeting was called to order at 7:00 p.m.

The Pledge of Allegiance was recited and meeting notice postings verified.

**MINUTES** Minutes of the March 10, 2014 Regular Board meeting, March 29, 2014 Special Board meeting and April 9, 2014 Rescheduled Public Hearing and Rescheduled Special Town Board Meeting were approved as read.

**TREASURER'S REPORT** Treasurer Kipping presented the March 2014 financial report.

**DISCUSSION AND ACTION** Agenda sequence changed, by agreement of all board members.

**Town Assessor, Board of Review:** Assessor Marv Nordquist informed the board that due to the state's mandate that all property assessments must comply with the state's electronic assessment data storage requirements, the tax roll won't be ready for the Board of Review in May.

The first meeting of the Board of Review will be Thursday, May 15, 2014 at 5:00 p.m. at the Scott Town Hall; the meeting will be opened and then adjourned to meet again at the Scott Town Hall Saturday, September 27, 2014.
