**BOARD MEETING**

The regular monthly meeting of the Scott Town Board was held Monday, December 9, 2013 at the Scott Town Hall. Chairman Peterson and Clerk Wiggins were present. A quorum being present, the meeting was called to order at 7:05 p.m.
