Supervisor John Vanous called the meeting to order at 7:00 PM. The Pledge of Allegiance was recited. Roll Call: Chairperson Jeff McIntyre (via teleconference), Supervisor John Vanous, Supervisor Bill Sobaski, Treasurer Carol Ann Jacobson and Clerk Ken Busby were present. Busby stated the agenda was posted at the A&H Country Market Bulletin Board, Outside the town hall door in the glass cabinet and on the town website on February 3, 2021.

AGENDA ORDER – Motion (Sobaski/McIntyre) to approve the agenda order. Motion carried 3-0.

MINUTES – January 11, 2021 Monthly Board Meeting Minutes. Motion (McIntyre/Sobaski) to approve the minutes. Motion carried 3-0.

FIRE CHIEF REPORT: Call as a mutual Aid to Webb Lake on February 7th. Rescue snowmobile was sent out for service and the repair cost was more than the value of the machine. Considering a Side-by-Side UTV as a replacement. Motion (Sobaski/McIntyre) to approve Brian Ohmann as the new fire chief. Motion carried 3-0. Motion (Sobaski/McIntyre) to approve Deni Olson as the Fire Secretary. Motion carried 3-0.

TOWN ROADS REPORT: Sobaski reported that the 2 man work crew is working out. The loader was scheduled to be delivered today or tomorrow. Found a couple of broken trusses on the town garage. Called Doug Brown for an estimate. Damage thought to be caused by snow load or tree branch falling on it at some point. Awaiting an estimate. Clerk will contact the insurance company. Ohmann mentioned Trailer debris is still at the recycle center. McIntyre said he would pursue the bill from the owner.

RECYCLING CENTER REPORT: Vanous reported that there was nothing new to report. Gary Lundberg spoke that the Recycling Control Commission did approve raising the rate of pay for the recycling attendant. They will do a study to see if the ratio formula can be changed.
