BOARD MEETING MINUTES

August 16, 2023, 7:00 PM

Chairperson Scott Barton called the meeting to order at 7:00 PM. The Pledge of Allegiance was recited. Roll Call: Chairperson Scott Barton, Supervisor Deni Olson, Treasurer Paul Kipping and Clerk Ken Busby were present. Supervisor John Vanous was not in attendance. Busby stated the agenda was posted at the A&H Country Market Bulletin Board, outside the town hall door in the glass cabinet and on the town website on August 14, 2023.

AGENDA ORDER – Remove Hanscom Lake Trail Driveway Discussion due to Vanous absence.

MINUTES – Motion (Olson/Barton) to approve the July 18, 2023 Special Board Meeting and July 10, 2023 Monthly Board meeting minutes. Motion carried 2-0.

FINANCIAL REPORTS – July 2023 Financial Statements were presented.

PUBLIC COMMENT – Mary Larson made a statement about ATV traffic on Kilkare Road. 150' to a dwelling and 100' of a person is supposed to be 10 MPH. Asking for better signage. Busby stated the county cannot afford to put up the proper signs. Barton relayed his recent experience and will see about getting some additional signage. Dan Linahon - Looking for an update on repair Hill Road. It was on the list for repair last year. The board explained the town didn't have the money this year to work on it due to increased expenses. Barton said he would take a look at the road.

ANNUAL PROPANE CONTRACT: Budgeted item. Submit contract for 4000 gallons. No need for further approval.
