BOARD MEETING MINUTES
Scott Town Hall
May 12, 2025, 7:00 PM

Chairperson Scott Barton called the meeting to order at 7:00 PM. The Pledge of Allegiance was recited. Roll Call: Chairperson Scott Barton, Supervisor John Vanous, Supervisor Rob Bauman, Treasurer Trisha Johnson and Clerk Busby were present. Busby stated the agenda was posted at the A&H Country Market Bulletin Board, the Town website and outside the town hall door in the glass cabinet on the May 7, 2025.

TOWN ROADS REPORT: Bauman reported that we got a new asphalt heater and tried it out. It is working well. The county let us talk with their expert and he showed how best to use it. Need to decide what we are going to chip and seal this year. Board approved the road crew getting a credit card for incidentals.

RECYCLING CENTER REPORT: Vanous reported the center is open longer hours now. Things are working fine there. Vanous will check with NWRPC to see if we can get a new sign.

COUNTY SUPERVISOR REPORT: Emily Gall reported it is slow so far, but meetings will be next week. Joint Finance Committee State meeting in Hayward. Didn't seem to be of any benefit.

CHAIRMAN REPORT: Barton and Bauman are going to be attending the workshop in Cable, WI in a couple of weeks.
