BOARD MEETING MINUTES
Scott Town Hall
July 14, 2025, 7:00 PM

Chairperson Scott Barton called the meeting to order at 7:00 PM. The Pledge of Allegiance was recited. Roll Call: Chairperson Scott Barton, Supervisor John Vanous, Supervisor Rob Bauman, Treasurer Trisha Johnson and Clerk Ken Busby were present. Busby stated the agenda was posted at the A&H Country Market Bulletin Board, the Town website and outside the town hall door in the glass cabinet on the July 9, 2025.

AGENDA ORDER – Motion (Vanous/Bauman) to approve the agenda order. Motion carried 3-0.

MINUTES – Motion (Vanous/Bauman) to approve the June 9, 2025 Monthly and June 16, 2025 Special Board Meeting minutes. Motion carried 3-0.

FINANCIAL REPORTS – June 2025 Financial Statements were presented.

PUBLIC COMMENT: Jeff McIntyre asked to save his comment to the roads report and was granted. Harold McCann spoke asking about the liquor license he did not receive. Barton spoke that there is an appeal process. Barton asked Busby to get the appeal process to McCann.

REPORTS, DISCUSSION and ACTION

FIRE CHIEF REPORT: Busby noted that the new fire engine is here and fully operational.

TOWN ROADS REPORT: Supervisor Bauman reported that the crew is filling pot holes. One person is going to start mowing. It is planned to take 5 weeks to do it all. Looking to see prices if we hire someone to clear some trees. Also still looking to hire someone. Barton reported that Scott Construction came out to give us a quote for several roads. Johnson asked about Gold Star and Bauman said it would be best to wait until Camp Croix construction is done. McIntyre asked about crack sealing Pepin Road.

RECYCLING CENTER REPORT: Vanous reported that the July 4th weekend brought in some good money. New sign is in. McIntyre spoke of a portable speed bump idea.

COUNTY SUPERVISOR REPORT: County Supervisor Emily Gall reported there was no county meeting last month due to a lack of action items. Admin committee met today. Unfortunately, the county cannot afford to pay their deputies properly compared to surrounding areas. About a \$5/hr difference compared to Washburn County. Some services are going to be cut due to the federal government reducing their funding. Gall is stepping in for Chairman Taylor for the Northwood Tech committee.

CHAIRMAN REPORT: Barton wants to have an organizational meeting. Make sure the workers know the structure. Burnt down building is all cleaned up.
