BOARD MEETING MINUTES
Scott Town Hall
September 8, 2025, 7:00 PM

Chairperson Scott Barton called the meeting to order at 7:00 PM. The Pledge of Allegiance was recited. Roll Call: Chairperson Scott Barton, Supervisor Rob Bauman, Treasurer Trisha Johnson and Clerk Ken Busby were present. Supervisor John Vanous was unable to attend. Busby stated the agenda was posted at the A&H Country Market Bulletin Board, the Town website and outside the town hall door in the glass cabinet on the September 7, 2025.

AGENDA ORDER – Motion (Bauman/Barton) to approve the agenda order. Motion carried 2-0.

MINUTES – Motion (Bauman/Barton) to approve the August 11, 2025 Monthly Board Meeting minutes. Motion carried 2-0.

FINANCIAL REPORTS – August 2025 Financial Statements were presented.

PUBLIC COMMENT: Scott Gresback on Mooney Road asking if the Town could make their private road a town road. Barton said we can discuss it in the roads section of the agenda.

REPORTS, DISCUSSION and ACTION

ZONING CHANGE – 28811 COUNTY ROAD H: Busby explained that the property owner of 28811 County Road H is interested in rezoning the property from commercial to residential in order for it to sell easier. The board had no objections to rezoning it to Residential.

CUP AND ZONING CHANGE – NORTHWOODS EQUIPMENT, KESSLER ROAD: 1433 Kessler Road, Jason Towne recommended it be rezoned to commercial. 1477 already in progress. In total, 2 rezoning apps and 2 CUP apps. Board has no objections on either.

FIRE CHIEF REPORT: Chief Ohmann reported its been pretty quiet. Did some Public Relations over the weekend with Voyager Village Fly-In.

TOWN ROADS REPORT: Supervisor Bauman and Road Boss John Meagher reported there has been patching, mowing, cutting back brush and recycling center hauling. Looking to burn a brush pile at the recycle center. Resident Scott Gresback on Mooney Road spoke and gave a sketch on what he is requesting. Says there is room enough for a turn around. Road is currently a width of around 20 feet made of class 5 gravel. Gresback is looking to get a couple loads of class 5 to be delivered and snow plowing. Third thing is taking care of fallen trees. Barton explained that he contacted the WTA and the Town cannot expend money on a private road. All the residents on the road would need to petition the board to make the road a town road. Certain changes would need to be made first to bring the road up to specifications.

RECYCLING CENTER REPORT: Supervisor Bauman spoke that it is going well. Things are moving in and out just fine. Clearing out some area for wood.

COUNTY SUPERVISOR REPORT: Not present

CHAIRMAN REPORT: Barton will look at the new truck information given to him. Budget meeting on October 6 at 1:30 PM.

VOUCHER APPROVAL / REJECTION, REVIEW AND PAYMENT OF CLAIMS: Motion (Bauman/Barton) to accept the vouchers. Motion carried 2-0.
