BOARD MEETING MINUTES
Scott Town Hall
November 10, 2025, Immediately Following Electors Meeting

Chairperson Scott Barton called the meeting to order at 7:12 PM. The Pledge of Allegiance was recited. Roll Call: Chairperson Scott Barton, Supervisor Rob Bauman, Treasurer Trisha Johnson and Clerk Ken Busby were present. Supervisor John Vanous was unable to attend. Busby stated the agenda was posted at the A&H Country Market Bulletin Board, the Town website and outside the town hall door in the glass cabinet on the November 7, 2025.

AGENDA ORDER – Motion (Bauman/Barton) to approve the agenda order. Motion carried 2-0.

MINUTES – Motion (Bauman/Barton) to approve the October 13, 2025 Monthly Board Meeting minutes. Motion carried 2-0.

FINANCIAL REPORTS – October 2025 Financial Statements were presented.

PUBLIC COMMENT: McIntyre asked to wait until the Roads Report

REPORTS, DISCUSSION and ACTION

PETERBILT CHASSIS PURCHASE DOLLAR AMOUNT CHANGE: Motion (Barton/Bauman) to amend the purchase price of the Peterbilt chassis to, Not-to-Exceed \$150,000. Motion carried 2-0.

APPROVE 2026 BUDGET: Motion (Barton/Bauman) to accept the proposed 2026 Budget. Motion carried 2-0.

STORAGE: Barton explained we are trying to organize the storage to accommodate all the Town's equipment. The board is looking to work with the Fire Department and their space. Some of the space needed will only be short term until old equipment is sold.

FIRE CHIEF REPORT: Chief Ohmann spoke of a call involving a family dispute, breaking a propane line. New Fire Engine winter prep is being handled.

TOWN ROADS REPORT: Supervisor Bauman reported chip sealing done, though not completely satisfied. Brushing was done and a lot of shouldering. Decided to hold on to the chip sealing check to Scott Construction until some assurances get communicated. McIntyre stated that he informed the Town in the spring that Dubois Road had 75 cracks and Pepin had 50. He recommends getting it crack sealed. Road Boss, John Meagher and Barton mentioned other roads like Kilkare to Hanscom need it as well and will need to figure it out.

RECYCLING CENTER REPORT: Supervisor Bauman reported things are going well. People like the changes.

COUNTY SUPERVISOR REPORT: County Supervisor Emily Gall was present. County is approving the budget this month. Money is tight and will need to be closely watched throughout 2026. Wisconsin has pushed through maintaining SNAP benefits despite the government shutdown. 62 county fraud cases were investigated and only 2 were valid fraud, so in general, neighbors are good people.

CHAIRMAN REPORT: Nothing to mention.

VOUCHER APPROVAL / REJECTION, REVIEW AND PAYMENT OF CLAIMS: Motion (Bauman/Barton) to accept the vouchers. Motion carried 2-0.
