**BOARD MEETING MINUTES**  
Scott Town Hall  
December 8, 2025, Immediately Following Electors Meeting

Chairperson John Vanous called the meeting to order at 7:00 PM. The Pledge of Allegiance was recited. Roll Call: Chairperson Scott Barton (via speakerphone), Supervisor John Vanous, Supervisor Rob Bauman, Treasurer Trisha Johnson and Clerk Ken Busby were present. Busby stated the agenda was posted at the A&H Country Market Bulletin Board, the Town website and outside the town hall door in the glass cabinet on the December 3, 2025.

**AGENDA ORDER** – Motion (Bauman/Vanous) to approve the agenda order. Motion carried 2-0.

**MINUTES** – Motion (Vanous/Bauman) to approve the November 10, 2025 Monthly Board Meeting minutes. Motion carried 2-0.

**FINANCIAL REPORTS** – November 2025 Financial Statements were presented.

**PUBLIC COMMENT:** None

**REPORTS, DISCUSSION and ACTION**

**APPROVE ELECTION INSPECTORS FOR 2026-2027 TERM:** Busby presented the proposed list of Election Inspectors that said they would be interested in serving in the capacity. Motion (Bauman/Vanous) to approve the list of Election Inspectors. Motion carried 2-0.

**APPROVE NAMES TO SIGN LOAN DOCUMENTS:** Motion (Bauman/Vanous) to make Scott Barton and Kenneth Busby signers on the loan for the Peterbilt chassis. Motion carried 2-0.

**APPROVE CHASSIS DOWN PAYMENT:** Busby was able to give the year-end financial update to include the expenditures to date. Looking at the unassigned funds and expected expenditures for the final few weeks of the year, there looked to be no problem putting 20%, or about \$29,000 down on the new chassis. Motion (Bauman/Vanous) to make the down payment of the chassis 20%, not to exceed \$30,000.

**FIRE CHIEF REPORT:** Chief Ohmann spoke of new fire engine pump is all set for winter. Not much action yet. Wondering about disposition of truck #11. Vanous said we could get more money for it by stripping it down and selling it as a chassis.

**TOWN ROADS REPORT:** Supervisor Bauman reported brushing and burning brush. Tractor has had some issues with the relays they are working on.

**RECYCLING CENTER REPORT:** Supervisors Bauman and Vanous reported snow needs to be brushed off the panels, so the batteries went dead. Generator option considered.

**COUNTY SUPERVISOR REPORT:** County Supervisor Emily Gall was present. Slow this time of year. Passed the budget with no public comment. Will be running for office again and has her nomination papers.

**CHAIRMAN REPORT:** Nothing to mention.

**VOUCHER APPROVAL / REJECTION, REVIEW AND PAYMENT OF CLAIMS:** Motion (Bauman/Vanous) to approve the vouchers. Motion carried 2-0.
